Dayshift took two people to jail today, the first being a female who was refusing to leave a gas station after being told to leave. A short time later a male was seen throwing rocks at a car, Officers arrived in the area quickly and located him. He was positively ID as the suspect, the damage to the vehicle was over one thousand dollars and he was taken to jail.

SUPERVISOR COMMENTS

The shift was steady all evening with most calls requiring multiple unit responses. One call in particular, began as a civil dispute over a sold vehicle involving multiple people. While

officers were on scene, they were told that one of the involved males had a gun. Eight males were pruned out at gunpoint and detained. Once the scene was secure, no gun was located and it was determined a male motioned under his sweatshirt that he had a gun but none was seen. One of the males detained was found to have a felony juvenile warrant out of San Mateo County and was booked in Juvenile Hall. Officers responded to three different calls of suicidal subjects who were detained for mental health evaluations. Officers also responded to a domestic dispute where a male assaulted his girlfriend and stole items from her before fleeing on foot. He was not located but is wanted for felony domestic violence and robbery.
