
VICINITY MAP

2. FIRE EXTINGUISHERS W/ MINIMUM RATING OF 2-A:10-B:C SHALL BE PROVIDED NO FURTHER THAN 75-FT WALKING DISTANCE. TOP OF THE EXTINGUISHER SHALL BE MOUNTED NO MORE THAN FOUR (4') FEET ABOVE FINISHED FLOOR. (SEE SHEET XXXX FOR LOCATIONS)

3. ALL DRAPES, HANGINGS, CURTAINS, DROPS, AND ALL OTHER DECORATIVE MATERIALS SHALL BE TREATED AND MAINTAINED IN A FLAME RETARDANT CONDITION APPROVED BY THE STATE FIRE MARSHALL.

4. PROVIDE ALL-WEATHER, APPROVED SIGNAGE FOR THE "MAIN GAS SHUT-OFF" AND THE "MAIN ELECTRICAL DISCONNECT" PER FIRE DEPARTMENT STANDARDS. (WHITE BACKGROUND WITH RED LETTERS OR RED BACKGROUND WITH WHITE LETTERS. MIN. 3" LETTERS.)
